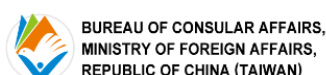

Visitor Visas for Foreign Exchange Students for Stays of less than Six Months

Requirements	Description
Application form	Fill out the application form at https://visawebapp.boca.gov.tw/ and print it out. Make sure the application form displays a bar code. Sign the completed application form.
Two color passport-size photos	Two color passport-size photos with a white background taken within the past 6 months, attached to the application form.
Original and one photocopy of the passport	<ol style="list-style-type: none"> Applicant's passport must have remaining validity of at least six months as well as blank pages. One photocopy of the passport bio-page, including the passport-holder's picture, is required.

R.O.C.(Taiwan) overseas missions to halt processing of visa applications during Taiwan's nationwide Level 3 epidemic alert in accordance with strict border control measures imposed by CECC.

The Central Epidemic Command Center (CECC) announced today that strict border control measures will continue to be implemented during Taiwan's nationwide Level 3 epidemic alert. In accordance with these measures, entry to Taiwan has been suspended for foreign nationals not holding a valid R.O.C.(Taiwan) Resident Certificate. Exceptions are being considered on a case-by-case basis for emergencies and on humanitarian grounds.

In line with this anti-pandemic policy, R.O.C.(Taiwan) overseas missions are halting the processing of visa applications during the nationwide Level 3 epidemic alert. Entry has also been suspended for persons holding a valid visitor visa or resident visa. Foreign nationals requiring entry to Taiwan for emergencies or humanitarian grounds, such as attending a funeral or visiting a critically ill family member, must receive special permission from the CECC before applying for a special entry permit visa from R.O.C.(Taiwan) mission.

The above-mentioned measures may be adjusted by the CECC at any time in accordance with the status of the pandemic and associated operations. (E)

If you have applied for an entry permit, please make sure your entry permit has been successfully issued. If you submit a second entry application without checking the approval of the previous entry permit, it is considered that you need 2 visas. Therefore, the online payment for these 2 visas applications will not be refunded.

Continued use of this system indicates that you consent to the terms set forth in this statement. Unauthorized users or illegal access may violate related articles of Personal Information Protection Act and Criminal Law.
